NEW BUSINESS

Executive Director Comments

- 1. Union according to our last notice ballots were mailed to employees on November 8, 2012 and will be counted on November 29, 2012.
- 2. We are still waiting to hear the outcome of the SWFWMD applications for funding in 2014.
- 3. Spyder update the engine has been removed and is out for rebuilt. One of the planetary wheel seal is completed and there are some problems with the other wheels. The planetary gears are worn out and are waiting to confirm an availability date on gears; the pins that hold the cylinders in place will have to be burned out.
- 4. Channel 3 Scour Repair All American Concrete has completed this project under the Minor Service Contract in the amount of \$52,000.00.
- 5. At 4:37 PM today received e-mail from McKim & Creed on Channel 4 Failure W of 66 Street after ongoing negotiations since July 2012. Janet Rogers, Executive Director recommends the Board agree to pay \$125,000.00 which will be put toward the repair. Discussion was held on breakdown of costs and other options. Jennifer Cowan, Attorney, stated each Board Member can speak to Jan or herself individually. Mr. Farrell gave directive for the Executive Director to continue based on the e-mail received on an offer from McKim & Creed to work with the District's Attorney toward a final agreement based on items outlined in e-mail received from McKim and Creed.
